

# The March 2023 Maple Leaf

#### Administration

We had a delay in getting the packet ready for the Annual Meeting because we wanted to have the most complete snapshot of the pool report to share. On Tuesday, February 21st, a group consisting of contractors enlisted by Zobrist Construction, our project manager from Farnsworth met with our pool committee, officers and some members we asked to join us for their insight and experience.

A timeline was agreed upon to complete the repairs with work starting earlier this week. Contractors were given a deadline to finish all work so the pool would be ready to open as scheduled by Memorial Day weekend. The final costs are anticipated to come in between \$130,000 / \$140,000. It is more than we wanted to spend certainly. But if it creates a window of opportunity for the finance committee to develop an initiative for a long-term replacement strategy, I think it's a worthwhile investment.

We have the funds allocated to account for this spend but the board is planning to send out a one-time assessment per membership for the sole purpose of maintaining our capital improvement account. Each member will be assessed a 5<sup>th</sup> quarter that will be due on, or before, June 1st.

Full-Time Members will be invoiced \$275, Starter Members will be billed \$150. And to be clear, no funds from our Golf Improvement fund have been, or will be, used to cover this investment. We are still in the market for new fairway equipment for the golf course and are only using our Golf Improvement funds for golf.

But our pool is tired, and we need to take advantage of this window to investigate our options at replacing the aging structure. The dollars required are significant.

Conservative estimates range anywhere between \$1.5 and \$3 million.
